# 16-081 <u>Municipal Plan Amendment - Public Consultation Process -355</u> O'Connell Drive

Murphy, it is RESOLVED to authorize staff to carry out a public consultation process, as per section 14 of the Urban and Rural Planning Act, in order to seek public input and receive information with respect to the proposed Municipal Plan amendment and Development Regulations amendment in order to change the land use designation and land use zoning of land located on O'Connell Drive, specifically a portion of the lot identified as 355 O'Connell Drive, from Residential (land use designation) and Residential Medium Density (land use zoning) to Light Industrial (land use designation and land use zoning). The amendments are necessary in order to enable the existing lot to be completely located within the Light Industrial land use and zoning designations. **MOTION CARRIED.** 

# 16-082 <u>Municipal Plan and Development Regulations amendments MP15-06</u> and DR15-06

On motion by Councillor M. Murphy, seconded by Councillor T. Buckle, it is RESOLVED, under Section 23 of the Urban and Rural Planning Act, the Corner Brook City Council approve Development Regulations Amendment DR15-06 to:

- 1. Permit the "amusement" classification of use as a discretionary use of the General Industrial Use Zone Table by adding the classification to the Discretionary Use Class Table of the Zone.
- 2. Permit the "general assembly" classification of use as a discretionary use of the General Industrial Use Zone Table by adding the classification to the Discretionary Use Class Table (with an asterisk) of the zone and by adding a new condition which limits examples of the use classification to gymnasia, bowling alleys and other similar indoor recreational/fitness facilities.
- 3. Permit the "general assembly" classification of use as a discretionary use of the Light Industrial Use Zone Table by adding the classification to the Discretionary Use Class Table of the zone and by adding a new condition which limits examples of the use to indoor recreational facilities such as gymnasia, including climbing apparatus and/or facilities, bowling alleys, and similar recreation and fitness uses. **MOTION CARRIED.**

# 16-083 <u>Municipal Plan and Development Regulations Amendments MP16-01</u> <u>and DR16-01 –-Georgetown Road</u>

Murphy it is RESOLVED, under Section 23 of the Urban and Rural Planning Act, the Corner Brook City Council approve Municipal Plan Amendment MP16-01 to change the land use designation of land at Georgetown Road from Light Industrial to Residential. **MOTION CARRIED**.

# 16-098 Prince Street - Land Lease Request for Parking

# 16-099 <u>Main Street Bridge Replacement - Option Selection</u>

On motion by Councillor L. Chaisson, seconded by Councillor K. Cormier it is RESOLVED to approve the detailed design for the Main Street Bridge based on the following option selections:

- New bridge to be 4 lanes
- Girder type to be steel, with the finish being hot dipped galvanizing
- Girder length to be the short option to allow for maximum hydrological clearance
- Construction technique to be the Accelerated Bridge Construction method to reduce the planned traffic closure from 19 weeks down to 7 weeks
- Aesthetic details to be identified and presented to Council as the design advances
