16-204 FCM - Committee's

Mayor Pender advised that the FCM's Board of Directors established standing committees to enable more comprehensive discussion and provide the board with recommendations on priority policy and program issues. Each committee will have municipal elected officials and board members.

As a Director on the FCM board, Mayor Pender has been appointed to participate in the following standing committees;

- 1. Environmental Issues & Sustainable Development
 - a. Green economy, climate change adaptation, clean air, water, waste, wastewater, brownfields, toxic substances (including pesticides), energy, invasive species, green infrastructure
- 2. Social Economic Development
 - a. Housing and homelessness; cultural and community infrastructure, immigration and municipal-Aboriginal relations, aging.

16-205 60th Anniversary Update

Councillor M. Murphy provided a report on the 60th anniversary.

16-206 Public Notice - Business Improvement Program

Councillor L. Chaisson reminded residents that the Business Improvement Program (BIP) 2016 is concluding on the 16th September 2016. The application and approval processes have been made simpler to encourage more applications. The deadline for receiving completed applications is 4:00 pm on Friday, 16 September 2016.

Applications pertaining to work not started/completed must be pre-approved before the actual work is undertaken. Applications that have already commenced or completed the improvement, will also be considered provided

the relevant building permit was obtained in 2016. In both cases, all works must be completed before 31 December 2016.

Approved projects will be given a one-time tax credit of 50% of the total actual expenses, subject to a maximum credit limit of \$10,000.

A property can be considered only once under the BIP.

Councillor L. Chaisson advised that applications must be complete in all respects to be considered. After the application deadline (16 September), the evaluation committee will examine all the applications according to various pre-defined criteria. It may be emphasized that the total tax credit budget for 2016 being \$50,000, some applications, even though complete, may not qualify for the tax credit.
