WHEREAS the City requires the management and sales of graphic advertising in public transit shelters.

AND WHEREAS DAS is will provide sales and management services to the City on the terms and conditions specified herein;

NOW THEREFORE IN CONSIDERATION of the sum of \$1.00 and other valuable consideration (the receipt and sufficiency of is hereby acknowledged by both parties hereto) now paid by each party to the other, the parties hereby agree as follows:

1. OPERATION AND PAYMENT

- A. The City hereby grants unto DAS advertising rights for the display cabinets in the requested bus shelters (hereinafter called the "Display Cabinets") in the areas as listed Schedule "A" attached hereto for a term of three (3) years commencing on the 1st day of June, 2019 (the "Commencement Date") and ending on the 31st day of May, 2022 ("The Term").
- B. DAS agrees to be responsible for all activities related to Display Cabinets advertising in compliance with all regulations. This includes the procuring of advertisements and finalizing contracts, design and copywriting (where necessary); printing according to specifications and standards required by advertisers and placing the advertisements; and disposing old advertisements at end of contract.
- C. DAS agrees to provide the advertising through the Display Cabinets at all times for the duration of the contract.
- D. DAS agrees to pay the City a commission of fifty percent (50%) of all gross sales made through transit shelter adverting during the Term

 - VIII. Buck or Two Murphy Square (x1)
- F. Provide the City with a discount of 50% on additional indoor ad slots that they may want to buy to increase the intensity of their message delivery.
- G. Provide the City with a discount of 50% (on regular monthly rate) on outdoor digital billboards owned by DAS. This would be limited to four ads in total per month.

2. CONTRACTOR PROPERTY

DAS is responsible to inspect, maintain, repair and clean to the satisfaction of the City all cabinets and other supplies needed to provide advertising services. All such property stored, kept, used or employed at the bus shelters is at the DAS's own risk and the City shall not be responsible for any lost, stolen or damaged property.

3. CITY COVENANTS

The City covenants to:

A. Provide the initial display cabinet hardware. There are currently a total of 19 shelters, of which 6 have display cases

installed. The City will be installing additional display cases in the remaining bus shelters as operational and financial resources are available.

4. CONTRACTOR COVENANTS

The Contractor covenants to:

- A. Not assign or transfer the display cabinet advertising, or any of its rights or obligations under this Agreement, without the consent of The City, provided that such consent may be arbitrarily refused by The City in its sole and absolute discretion;
- B. At its own expense obtain all licenses and permits that may be required for and in connection with provision of the Display Cabinet advertising;
- C. Co-operate with The City and/or its duly authorized representatives, in such tasks as requested pertaining to the Display Cabinet advertising;
- D. To operate in a safe manner and in strict conformity with all conditions and obligations set out in its insurance policies and in compliance with all federal, provincial and municipal laws, by-laws, rules and regulations and building policies or other authority which in any manner affect or relate to the sale, use and provision of the Display Cabinet advertising services, including but not limited to obtaining all necessary permits and licenses and ensuring that all workers are trained and adhere to Occupational Health and Safety standards and national safety standards and to save The City harmless from any liability or cost suffered by it as a result of failure of the Contractor to do so;
- E. At its own expense, keep and maintain the Display Cabinets in a clean, sanitary, attractive condition that is satisfactory to The City;
- F. Generate and pursue advertisement leads and inquiries to maximize advertising revenue by means of procuring advertising orders;
- G. Develop and sign shelter advertising contracts with external clients including payment terms;
- H. Provide or procure advertisement design and copywriting services as needed;
- Organize advertisement printing services for the advertising clients if required;
- J. Install new advertisements in Display Cabinets and dispose of old advertisements in accordance with City of Corner Brook waste regulations for the duration of each advertising

- contract with individual clients;
- K. Submit a copy of all advertising contract signed to The City within three (3) business days;
- L. Submit accounts to The City every six (6) months;
- M. Submit all advertisements to The City and secure the City's written approval prior to placement in the Display. Displays must not include graphics that portray pornographic or offensive material, election or political advertisements, or any other themes and images that may be deemed inappropriate by the City;
- N. Not sell advertising space for a duration exceeding the remaining term of the contract. All contracts signed by the Supplier with the advertisers will become void on the last day of this contract, regardless of their specified or agreed duration of validity.
- O. Work closely with The City and provide professional advice as necessary for optimal use of advertising space, increase revenue and project a professional image in the community;
- P. To advise the City of any and all customer service feedback that may result from their operation of the Display Cabinets, and to take such corrective action as deemed necessary by The City to remedy any customer service concerns raised;
- Q. To participate in any customer service feedback program(s) or procedures implemented by The City;
- R. To allow for inspection of the Display Cabinets at the end of the term and provide repair or replacement at the discretion of The City.

6. TERM OF CONTRACT:

The contract will be in effect for a three year effective the signing date of this agreement. Subject to the approval of both parties, there shall be an option to renew for an additional three year term. The option must be exercised, in writing by both parties at least one hundred and eighty (180) days prior to the expiry of the agreement.

7. TERMINATION:

a) Notwithstanding the Term set out in this agreement, if at any time DAS is in default in the performance of any covenants, terms and conditions herein set forth to be performed, the City shall have the right to terminate this Agreement forthwith by serving DAS with a written notice of its' intention to terminate containing the date on which the termination will be effective and the reason(s) for termination. In such instance, DAS shall not be entitled to any payment in respect of such termination, including, without prejudice to the generality of the foregoing, any payment for any consequential loss or damage or loss of profits arising from termination of this Agreement or in any other way related thereto.

- b) Either party may terminate this Agreement by providing the other party with at least six (6) months written notice. Neither party shall be entitled to any payment in respect of such termination, including, without prejudice to the generality of the foregoing, any payment for any consequential loss or damage or loss of profits arising from termination of this Agreement or in any other way related thereto.
- 8. Any notice, document or other communication required or permitted to be given hereunder shall be sufficiently given if delivered or sent by prepaid registered mail or hand delivered as follows:

Each of the parties shall be entitled to specify a different address by giving notice in writing in accordance with the terms hereof. Any such notice, if mailed, shall be deemed to have been given on the fifth (5th) business day following mailing.

- 9. This Agreement shall be binding upon and inure to the benefit of the Parties and their respective successors and assigns. Neither this Agreement nor any variation or modification of this Agreement or waiver of any terms or provisions hereof shall be deemed valid and binding unless in writing and signed by an Officer of the Parties. Failure by either party to enforce any terms hereof shall not be deemed a waiver of future enforcement of that, or any other term.
- 10. DAS agrees that in performance of its services under this agreement neither DAS nor any person employed by or acting as agent for DAS shall be or be deemed to be an officer, servant or agent of the City or Corner Brook City Council. DAS and its employees and agents shall act throughout as independent contractors and shall not be or be deemed to be an employee or agent of the City or Corner Brook City Council.

- 11. DAS shall indemnify the City against all claims by any person, firm or corporation arising from the conduct of work by or through any act of negligence of DAS or any agent, contractor, servant, employee or licensee of DAS, and against all costs, counsel fees, expenses and liabilities incurred in relation to any claim or action or proceeding brought thereon.
- 12. The City and Corner Brook City Council shall not be liable for any death or injury of any kind to any person or persons (including but not limited to those under or in connection with the Workplace Health, Safety and Compensation Act, RSNL 1990 Ch. W-11, as amended, or any successor legislation) or with respect to any loss of or damage to property arising out of any act or omission of DAS its servants or agents in the performance of his, her, its or their obligations under this Agreement. DAS shall indemnify and save the City of Corner Brook and Corner Brook City Council harmless from and against all claims, demands, losses, costs, debts, damages, expenses, actions, suits or other proceedings and all liability therefrom arising.
- 13. DAS shall, at all times during length of this agreement, at its own expense maintain in force comprehensive public liability insurance with respect to the building housing the animal care facility and office of the City's animal control officer, and shall provide the City with certificates of a policy or policies of an insurance company or companies for:
 - a. Liability insurance for bodily injury and death with a limit of not less than Two Million (\$2,000,000.00) dollars.

Every policy or policies of insurance maintained by DAS shall name the City an insured and provide for cross-liability coverage. A. Status of 2017 Objective(s)

The City was able to recover 48.4% of the 2017 outstanding tax receivable balance by December 31, 2018.

Summary of reasons for meeting / not meeting the (Prior Year) objective include:

A number of business accounts have fallen significantly in arrears. Additional collection efforts are in place, but they will take time to enforce and collect. Tax sales that took place in the fall of 2018 were not completed and closed until early 2019 and were still on the AR list at the end of the year. Additional legal collection efforts are being planned for a number of accounts with arrears and where other collection efforts have not been successful.

B. 2018 Objective(s)

The City's objective is to recover 50% of the outstanding tax receivable by December 31st each year.

In order to ensure the availability of sufficient municipal services, it is important that residents and businesses make their payments to Council by March 31, or otherwise be placed on the City's arrears listing and held subject to the City's arrears recovery actions as presented in this report.

Under the Government of Newfoundland and Labrador's Community Sustainability Partnership (CSP), the City must implement and maintain a Tax Recovery Plan and Tax Receivable Summary by establishing objectives, timelines and procedures to recover unpaid taxes from the current and previous years.

The City is subject to these accountability measures in order to receive future a share of Provincial Gas Tax Revenue Sharing funding.

The City must also present municipal audited annual financial statements in compliance with Public Sector Accounting Board (PSAB) standards and an approved annual budget to receive municipal operating grants.

Moreover, the City will take all reasonable actions towards the recovery of taxes in arrears while ensuring the tax recovery process being followed is fair and reasonable to the tax payer and the City, and within the authority provided under the *City of Corner Brook Act, 1999*.

Exemption Summary:

SUBJECT: Recreational Vehicles Regulation, 2019

DESCRIPTION: The current Recreational Vehicles Regulation prohibits the operation of all recreational vehicles inside the City of Corner Brook. For quite some time City officials have been assessing options for the establishment of routes that would allow ATV access into the City. Over the past several month staff have intensified its focus on ATV access in an effort to capitalize on the tourism potential of this industry, while taking into consideration safety concerns, best practices of other municipalities and the overall impact on residents. Currently, All-Terrain Vehicle (ATV) operators are forced to bypass our City because it lacks a safe permitted ATV route. Information that has been garnered in consultation with the tourism and the All-Terrain Vehicle community and residents leads us to believe that the City is missing out on a tourism opportunity which would bring the touring ATV riders inside our City. Such access would provide ATV enthusiasts with access to our amenities and thereby generate added revenues for our business community. This new regulation will eliminate the ban on ATV operation inside our City and will establish a designated route that the ATV operators can travel through our City availing of amenities along the way. Note that this regulation permits use of all-terrain vehicles and does not permit use of snowmobiles.

PROPOSED MOTION: it is **RESOLVED** to adopt and enact the Recreational Vehicles Regulation 2019, and thereby repeals the current Recreational Vehicle Regulations that were enacted April 21st, 2008.

IMPLICATIONS OF RECOMMENDATION:

Staff Recommendation:

Based on information that has been garnered from the All-Terrain Vehicle community and residents, staff supports this initiative and feel it will be a great economic generator to our tourism industry by providing ATV community access to our City. By providing access via a designated route, touring ATV riders will enter our City and avail of its amenities. It is anticipated such access could be a boost to our business community. While concerns have been expressed that ATVs may present a new risk to the designated roadways, this risk has been assessed and is minimized by compliance to the operating rules set forth in the proposed regulation. The routes will be monitored by the Royal Newfoundland Constabulary and our municipal enforcement officers and operating rules will be strictly enforced. Staff will be viewing this initiative as a trial project and will monitor it closely to address any safety concerns and better understand whether the project truly benefits our City.

Legislative Authority:

Sections 201 and 202 of the City of Corner Brook Act authorize Council to make regulations prohibiting or controlling the operation of recreational vehicles not licenced under the Highway Traffic Act on public roads and bridges; Section 10 of the Motorized Snow Vehicles and All-Terrain Vehicles Act, 1990 authorize Council to make regulations permitting the driving of vehicles or a class of vehicles along or across a highway or part of a highway in a municipality;

Communication Strategy: Communication of this initiative will be coordinated by the City's information officer who will avail of social media, print media, media interviews, etc. to educate our communities of this new initiative. To date the

City has received comments from 94 people with 65 supporting the proposed bylaw while 29 oppose. Those against the new regulation cite concerns related to safety, traffic congestion, air and noise pollution. Those in support comment that such change will be a benefit to tourism and our local economy.

<u>Pursuant</u> to the provision of section 10 Motorized Snow Vehicles and All-Terrain Vehicles Act, R.S.N.L 1990 c. M-20 and sections 201 and 202 of the City of Corner Brook Act, R.S.N.L. 1990 c. C-15 and all other powers it enabling the Corner Brook City Council in a session convened on the __ day of May, 2019, hereby passes and enacts the following regulations:

Title

1. These Regulations may be cited as the City of Corner Brook Recreational Vehicles Regulations.

Definitions

- 2. In these Regulations:
 - a. "All-terrain vehicle" means a wheeled motorized vehicle, excluding a two wheeled vehicle, designed or adapted for off-road use;
 - b. "City" means City of Corner Brook;
 - c. "Council" means Corner Brook City Council;
 - d. "Director" means the Director of Protective Services;
 - e. "Enforcement officer" means a municipal enforcement officer as defined by the City of Corner Brook Act R.S.N.L. 1990 ch.C-15 as amended or a peace officer as defined by the Highway Traffic Act;
 - f. "Highway" means any public highways, streets or roads assumed and maintained under the ownership and jurisdiction of the City of Corner Brook;
 - g. "Highway Traffic Act" means the Newfoundland and Labrador Highway Traffic Act RSNL 1990 Chapter H-3 as amended;
 - h. "Motorized snow vehicle" means a tracked vehicle, commonly known as a snowmobile, where the driver sits astride a seat and which is designed for operation over snow covered land and ice;

- "Motorized Snow Vehicles and All-Terrain Vehicles Act" means the Newfoundland and Labrador Motorized Snow Vehicles and All-Terrain Vehicles Act, RSNL 1990 Chapter M-20;
- j. "Permitted route" means any highway or public pathway approved by Council for all-terrain vehicle use and set out in Schedule A;
- k. "Public pathway" means any pathway or trail assumed under the ownership of the City of Corner Brook or maintained under the jurisdiction of the City of Corner Brook;

Designated Routes

 All-terrain vehicles are permitted to be used on any highway or pathway as set out in Schedule A.

Prohibited Routes

- 4. Except as set out in Schedule A, no person shall use or permit to be used, an all-terrain vehicle on a highway or public pathway within the City unless:
 - a. prior written permission has been obtained from the Director and/or City Manager; and
 - b. the person adheres to any or all additional conditions and restrictions set out by the Director or City Manager.

Snowmobiles

Motorized snow vehicles are not permitted to be used on any highway within the City.

Rules of Operation

- 6. No person shall operate an all-terrain vehicle upon a City highway unless:
 - a. that person travels upon the designated route as outlined in Section 3 of these regulations;
 - b. the vehicle and its driver operate in accordance to the *Motorized Snow Vehicles and All-Terrain Vehicles Act*;;

- c. that person is at least 16 years of age and the holder of a class of driver's licence issued under the *Highway Traffic Act*;
- d. that person or the vehicle being driven carries a liability insurance policy and proof thereof can be readily produced when requested by an enforcement officer:
- e. the all-terrain vehicle is equipped with an exhaust system that is of the original equipment manufacturer and has not been modified to increase sound. The exhaust system must be in working order and in constant operation to prevent excessive or unusual noise;
- f. the all-terrain vehicle is operated at a rate of speed not greater than 20 kilometres per hour; and
- g. the driver of an all-terrain vehicle at all times yields the right of way to drivers of all other classes of motor vehicles on a highway.

Rules of the Road

7. Unless otherwise stated in these regulations, the driver of an all-terrain vehicle shall adhere to the "rules of the road" as described in Part V of the Newfoundland *Highway Traffic Act* or any similar or successor legislation.

Times of Operation

- 8. No person shall operate an all-terrain vehicle in accordance with this bylaw before June 1st or after October 31st of any year.
- 9. No person shall operate an all-terrain vehicle within the City and upon its highways earlier than 7 A.M. and no later than 30 minutes after sunset.

Signage

10. Council may erect Warning, Cautionary, Directional, Limiting or Prohibiting signs as to the operation of all-terrain vehicles and the operator of any vehicle who fails to obey such signs is guilty of an offence under these regulations.

Penalty

11. A person who contravenes or fails to comply with these regulations is guilty of an offence and where no penalty is otherwise prescribed for such offence in the

Motorized Snow Vehicles and All-Terrain Vehicles Act RSNL Ch.M-20, Highway Traffic Act RSNL 1990 ch. H-3 or any other Provincial Statutes or Regulations, is liable on summary conviction to a fine or to a period of imprisonment or both in accordance with section 438 of the City of Corner Brook Act RSNL 1990 Ch. C-15, as amended

Exemption

 These regulations do not apply to vehicles owned and operated by the Council or those operated by Emergency and or Enforcement Services and other persons who are exempt by the provisions of the Motorized Snow Vehicles and All-Terrain Vehicles Regulations 1163/96.

Interpretation

- 13. These Regulations include the Schedules attached to them, and the Schedules are hereby declared to form part of these Regulations.
- 14. If a court of competent jurisdiction should declare any section or part of a section of these Regulations to be invalid, such section or part of a section shall not be construed as having persuaded or influenced Council to pass the remainder of the Regulations and it is hereby declared that the remainder of the Regulations shall be valid and shall remain in force..

Coming into Force and Repeal

15. These regulations shall come into force as of the date enacted by Council and the City of Corner Brook Recreational Vehicles Regulations April 5, 2008 are hereby repealed upon the coming into force of these Regulations.

Schedule "A"

Permitted All-Terrain Vehicle Routes

All-Terrain Vehicles are permitted to travel on or along the following highways:

- Riverside Drive
- Main Street
- Herald Avenue
- Broadway
- Pier Road
- Griffin Drive
- Petries Street (from the intersection with Curling Street to the intersection with Hilliards Road)
- Hilliards Road

All-Terrain Vehicles are permitted to travel on or along the following public pathways:

· Trail between the end of Pier Road and Griffin Drive
