C-15, as amended and all other powers, the Council of the City of Corner Brook hereby adopts and enacts the following amendments to the City of Corner Brook Traffic Regulations: 1} Under "Definitions", Section 2 c. "Director" means Director of Public Works, Water and Waste Water; (Previous version: "Director" meant "Director of Operational Services". This position no longer exists.) 2} Under "Overnight Parking", Section 9. No person shall park any vehicle on any highway within the City between the hours of 1:00 a.m. and 8:00 a.m., except for between December 1st and May 1st in the following year where vehicles shall not park on any highway within the City between hours of 12:00 midnight and 8 a.m. These Regulations shall not apply to ambulances or fire engines nor to motor vehicles operated by medical practitioners, clergy, police officers or City agents or employees, when being used in cases of emergency. {Previous version: No person shall park any vehicle on any highway within the City between the hours of 1:00 a.m. and 8:00 a.m. this will align the City bylaw with the Provincial Snow Clearing Regulations says from 12:00 midnight to 8:00 am during December 01 to May 01 of the following year.)

THIS AGREEMENT made at the City of Corner Brook in the Province of Newfoundland & Labrador this _____ day of October Anno Domini two thousand and eighteen.

BETWEEN <u>CORNER BROOK CITY COUNCIL</u>, a body corporate duly continued pursuant to the City of Corner Brook Act, R.S.N.L. 1990, c. C-15, as amended

hereinafter called "The City".

AND <u>HUMBER VALLEY COMMUNITY EMPLOYMENT CORPORATION</u>, a body corporate duly registered in the Province of Newfoundland and Labrador

hereinafter called "HVCEC".

WHEREAS the City wishes to have custodial services provided at Margaret Bowater Park;

AND WHEREAS HVCEC wishes to provide custodial services;

NOW THEREFORE THIS AGREEMENT WITNESSETH THAT for and in consideration of the mutual covenants and conditions herein set forth, the parties hereby agree as follows:

- 1. HVCEC agrees to provide the City with custodial services at Margaret Bowater Park ("The Park") located on O'Connell Drive in the City of Corner Brook, including the building thereon which houses the concession stand, washrooms and changerooms, commencing August 19th, 2018 and ending October 27th, 2018 ("The Term"). Hours of operation include 11:30 am to 7:30 pm.
- 2. The City agrees to pay to HVCEC the sum of Nine Thousand One Hundred and Ninety Five dollars (\$9195.00) for the provision of custodial services after such services have been provided to the satisfaction of the City in accordance with the provisions set out in this agreement upon completion of the services and after final inspection by the City on the 28th of October, 2018.
- 3. The City covenants to:

- A. Maintain the existing water supply when reasonably possible at the Park for the use of HVCEC in providing custodial services;
- B. Provide access to the Park as needed for provision of the custodial services;
- C. To inspect regularly and to notify HVCEC promptly of any dissatisfaction with provision of its custodial services; and
- D. Ensure the building at the Park is maintained for annual start up operations and annual facility shut down.
- 4. HVCEC covenants to:
 - A. Be responsible for the daily start up and shut down activities related to the custodial services and related equipment;
 - B. Provide the custodial services at the times and in the manners specified in its proposed cleaning contract and attachment to cleaning contract annexed hereto as Schedule "B";
 - C. Not assign or transfer the custodial services, or any of its rights or obligations under this Agreement, without the consent of the City, provided that such consent may be arbitrarily refused by the City in its sole and uncontrollable discretion;
 - D. At its own expense obtain all licenses and permits that may be required for and in connection with the provision of custodial services;
 - E. Co-operate with the City and/or its duly authorized representatives, in such tasks as requested pertaining to the provision of custodial services, including but not limited to facilitating the City's entrance to the building at the Park any time for any reason;
 - F. At all times observe and comply with and endeavor to ensure strict observance of and compliance with all statutory requirements, regulations, rules and/or by-laws of every municipal or other authority which in any manner affect or relate to the Park and/or building and/or the use of the Park and/or building, or any part thereof;

- G. Keep and maintain the washrooms, changerooms, building, and outdoor eating areas in a clean, sanitary, attractive condition that is satisfactory to the City and the Department of Health and Community Service for the Province of Newfoundland & Labrador and regularly ensure disposal of all garbage, waste and recyclable material and rubbish throughout the Park;
- H. Notify the City immediately with respect to any damage occurring to the Park, the building or the equipment therein;
- I. Not alter the Park, building or equipment without prior consent of the City;
- J. At all times indemnify and save harmless the City from and against any and all manner of claims, demands, losses, costs, charges, actions and other proceedings whatsoever, (including but not limited to those under or in connection with the *Workplace Health, Safety and Compensation Act, RSNL* 1990 Ch. W-11, as amended, or any successor legislation) made or brought against, suffered by or imposed on the City or its property in respect of any loss, damage or injury (including fatal injury) to any person or property (including, without restriction, invitees, employees, agents and property of the City and HVCEC) directly or indirectly arising out of, resulting from or sustained as a result of HVCEC's provision of custodial services;
- 5. If at any time HVCEC is in default in the performance of any of the covenants and agreements therein set forth to be performed by HVCEC, and such default continues for five(5) days after the receipt by HVCEC of notice in writing from the Director of Community Services of the City setting out the particulars of such default, the City shall have the right to terminate this agreement forthwith and thereupon all the rights of HVCEC hereunder shall immediately cease, determine and be at an end, and the City shall not be liable for payment to HVCEC of any moneys whatsoever by reason of such termination or otherwise howsoever, including but not limited to any damages for loss of business.
- 6. The City reserves the right to terminate this agreement for any reason without showing cause by giving ten (10) days written notice to HVCEC. Thereupon all the rights of HVCEC hereunder shall immediately cease, determine and be at an end, and the City shall not be liable for payment to HVCEC of any moneys whatsoever by reason of such termination or otherwise including but not limited to any damages for loss of business save and except for such custodial services that have been provided to the City up to the date of termination which payment shall be pro-rated in accordance with the number of days such services were provided as compared to the total number of days set out in the Term herein.

- 7. Upon failure by HVCEC to comply with any covenant(s) incumbent upon it under this Agreement within five (5) days after written notice requiring such compliance is given by the City to HVCEC, the City may fulfill such covenant(s) at the sole expense of HVCEC, who shall forthwith upon being invoiced therefor reimburse the City who in default of such reimbursement may collect same as a debt owing and in arrears. Nothing herein prevents the City from electing to terminate this tenancy for default as set out in clause #5 of this Agreement.
- 8. HVCEC agrees to indemnify the City for any damage to the Park, building or its furnishings and fixtures and any part thereof due to any act of HVCEC, its agents or employees, or of any person using the said premises by reason of the use thereof by HVCEC.
- 9. The termination of this Agreement shall not affect the liability of either party to this Agreement to the other with respect to any obligation under this indenture which has accrued up to the date of such termination but not been properly satisfied or discharged.
- 10. Any notice pursuant to any of the provisions of this Agreement shall be deemed to have been properly given if delivered in person, or mailed by prepaid registered post addressed:
 - (i) In the case of notice to the City to:

Or to such other address as either party may notify the other of, and in the case of mailing as aforesaid, such notice shall be deemed to have been received by the addressee, in the absence of a major interruption in postal services affecting the handling or delivery thereof, on the fifth (5th) business day, excluding

Saturdays, next following the date of mailing.

- 11. All sums, debts, payments or otherwise, payable to the City under this Agreement shall bear interest commencing the thirtieth (30th) day next following the falling due thereof, at the then current rate of interest charged to the City by its bankers until the actual date of payment.
- 12. HVCEC shall pay to the City all the City's legal costs on a solicitor and client basis, of all actions or other proceedings in which the City participates in connection with, or arising out of the obligations of HVCEC under this Agreement or arising out of HVCEC's provision of custodial services, except to the extent that the City is not successful therein.

SUBJECT: City of Corner Brook Traffic Regulation

DESCRIPTION: Each winter the City of Corner Brook issues a Parking Ban notification to its residents indicating that vehicles must not be parked on City streets between the hours of 1:00 am to 8 am, as per the City of Corner Brook Traffic Regulation. The City of Corner Brook Traffic Regulation prohibits parking year round between the hours of 1 am to 8 am, however it's not normally enforced during the spring, summer, or fall months.

The province issues a parking ban every winter, in accordance with the NL Snow Clearing Regulations, under which the Royal Newfoundland Constabulary issue their parking tickets. The NL Snow Clearing Regulations bans parking between the hours of 12:00 midnight to 8 am.

This difference in the start time of the parking restriction causes much confusion amongst the general public when the parking restriction comes into effect, be it 12:00 midnight or 1:00 am. To rectify this regulation conflict, we have added wording to our Traffic Regulations that coincide with the provincial winter parking ban regulations.

PROPOSED MOTION: it is RESOLVED to that the City of Corner Brook enact the following amendments to the City of Corner Brook Traffic Regulations:

1) Under "Definitions", Section 2 c. "Director" means Director of Public Works, Water and Waste Water;

2) Under "Overnight Parking", Section 9. No person shall park any vehicle on any highway within the City between the hours of 1:00 a.m. and 8:00 a.m., *except for between December 01st and May 1st in the following year where vehicles shall not park on any highway within the City between hours of 12:00 midnight and 8 a.m.* These Regulations shall not apply to ambulances or fire engines nor to motor vehicles operated by medical practitioners, clergy, police officers or City agents or employees, when being used in cases of emergency.

IMPLICATIONS OF RECOMMENDATION:

Staff Recommendation: Staff recommend adding a change to starting hours so to align the City bylaw with the Provincial Snow Clearing Regulations, which says from 12:00 midnight to 8:00am during December 01 to May 01 of the following year.

(1) Subject to any Act or regulation in force respecting the parking, drawing up or standing of vehicles in a city, municipality or other designated area of the province, a person shall not, during the period in each year that this regulation is in force, leave a vehicle unattended on a highway between the hours of 12 midnight and 8 a.m.

- (a) within 3 metres of the paved portion of the highway; or
- (b) if the highway is not paved, within 3 metres of the edge of the travel surface of the highway.

(2) Subsection (1) does not apply to a medical practitioner engaged in urgent medical business.

3. A person in charge of a vehicle who leaves the vehicle unattended in contravention of section 2 is guilty of an offence under the Act.

CITY OF CORNER BROOK TRAFFIC REGULATIONS

<u>PURSUANT</u> to the powers vested in it under Section 203 of the *City of Corner Brook Act*, R.S.N.L. 1990, c. C-15, as amended, Section 189 of the *Highway Traffic Act*, R.S.N.L. 1990, c. H-3, as amended, (a) delegation(s) of power by the Minister of Works, Services and Transportation dated ______ and all other powers it enabling, the Corner Brook City Council, in a session convened on the 21st day of April, 2008, hereby passes and enacts the following regulations.

1. This regulation may be cited as the *City of Corner Brook Traffic Regulations.*

Definitions

- 2. For the purpose of this regulation:
 - a. "City" means the City of Corner Brook;
 - b. "Council" means the Corner Brook City Council;
 - c. "Director" means the Director of Operational Services;
 - d. *"Highway Traffic Act"* means the *Highway Traffic Act*, R.S.N.L. 1990, c. H-3, as amended,
 - e. "Traffic Control Device" means any sign, signal or device erected by authority of the Council for the purpose of regulating, warning or guiding traffic and includes any signal by which traffic is directed to proceed or to stop and includes warning sign-posts, direction posts, signs, lines, marks or other devices for the guidance of persons using the highway;
 - f. "Traffic Officer" includes a member of the Royal Newfoundland Constabulary, a municipal enforcement officer and any person designated by Council as a Traffic Officer for the purpose of the Regulations, by whatever name or title such person is known.
- 3. No person shall use any highway within the City unless that person complies with all the provisions of the *Highway Traffic Act* and Regulations made thereunder, except insofar as the *Highway Traffic Act* or Regulations thereunder contain an exemption for Regulations or

provisions of Council, in which case such person shall comply with all applicable Regulations or provision of Council.

- 4. Nothing in these regulations shall prohibit the lawful parking of a vehicle in accordance with the *City of Corner Brook Parking Meter Regulation*.
- 5. Council or the Director may cause or permit Traffic Control Devices to be placed upon or near any highway within the limits of the City.
- 6. Without limiting the generality of Section 5 of these Regulations, traffic control devices may be used for any of the following purposes:
 - (a) to regulate the movement of traffic;
 - (b) to indicate the route to be followed by traffic;
 - (c) to restrict or prohibit the use of any part of any highway within the City;
 - (d) to indicate maximum speed limits in any area or on any part of any highway within the City;
 - to restrict or prohibit the parking of vehicles in any area or on an highway within the City and specifically to reserve particular areas for parking by specific types of vehicles or for the parking of vehicles operated by specific classes of persons;
 - (f) to restrict or prohibit temporarily the use of any highway, or any part of any highway within the City whenever, owing to the likelihood of danger to the public or of serious damage to the highway, it appears to the Council or the Director to be necessary; and to limit the loads of vehicles owing to conditions of any highway, if the Council or Director deems it necessary, provided that the sign shall not apply to any person granted a permit in writing by the Council to use the highway in case of emergency;
 - (g) to warn users of the highway of the need for special caution;
 - (h) to convey information to users of the highways within the limits of the City.
- 7. Except where a Traffic Officer directs otherwise, drivers and pedestrians shall obey the instruction of a Traffic Control Device.

- 8. a) No person shall drive any motor vehicle at a speed exceeding 50 kilometers per hour within the limits of the City except in areas otherwise designated by Council.
 - b) The Director may place restrictions on the speed at which a person shall drive a motor vehicle within the City when the Director, in his sole discretion deems it necessary to protect such street, road or highway or for public safety and the Director may cause to be placed such signs and signals as are necessary to advise persons of such restrictions, and such restriction shall remain in place until revoked by the Director or Council.
 - c) Council may at anytime revoke a restriction placed by the Director under this section.
 - (d) Every restriction or prohibition made by the Director under this section shall
 - i) within two (2) days (exclusive of Sundays and holidays) be communicated by the Director to Council; and
 - ii) Remain in full force and effect until revoked, altered, amended or varied by the Director or Council.

Overnight Parking

9. No person shall park any vehicle on any highway within the City between the hours of 1:00 a.m. and 8:00 a.m. provided that these Regulations shall not apply to ambulances or fire engines nor to motor vehicles operated by medical practitioners, clergy, police officers or City agents or employees, when being used in cases of emergency.

Directions of City Agents

10. The owner or operator of any motor vehicle shall move his or her vehicle on request to such position and for such time as may be reasonably required by an agent or representative of Council.

Public Parking Lots

11. A motor vehicle shall not be permitted to remain in a stationary position upon any public parking lot (other than a privately-owned lot) for a period in excess of 24 hours and in no instance shall the vehicle be allowed to obstruct traffic or any municipal undertaking including but not limited to snow-clearing.

Projections

12 No person shall operate any vehicle within the boundaries of the City having any object or thing projecting or extending therefrom in a lateral direction for a distance of more than 30 centimeters.

Offences and Penalties

- 13. Where any person contravenes any of the provisions of these Regulations, such person is guilty of an offence and liable on summary conviction to a fine or to a period of imprisonment in accordance with s. 438 of the *City of Corner Brook Act*.
- 14. These regulations shall come into force as of the date enacted by Council and the City of Corner Brook Traffic Regulations 1992 and all amendments thereto are hereby repealed upon the coming into force of these Regulations.
