

**CITY OF CORNER BROOK  
PARKS REGULATIONS**

PURSUANT to the powers vested in it under Sections 204 and 205 of the *City of Corner Brook Act*, R.S.N.L. 1990, c. C-15, as amended and all other powers it enabling, the Corner Brook City Council, in a session convened on the 21<sup>st</sup> day of April, 2008, hereby passes and enacts the following regulation.

1. These Regulations may be cited as the *City of Corner Brook Parks Regulations*.

**Definitions**

2. In these Regulations:

"all-terrain vehicle" means a wheeled or tracked motorized vehicle, designed or adapted for off-road use;

"City" means the City of Corner Brook;

"Council" means Corner Brook City Council;

"Director" means the Director of Operational Services;

"goods" means tangible personal property, fixtures, crops and the unborn young of animals, documents of title, chattel paper, a security, an instrument and money

"motorized snow vehicle" means a tracked vehicle, commonly known as a snowmobile, where the driver sits astride a seat and which is designed for operation over snow covered land and ice;

"motor vehicle" means a vehicle propelled, driven or controlled otherwise than by muscular power, other than a trailer, a vehicle running upon fixed rails, an all terrain vehicle or a motorized snow vehicle.

"Park" includes any land or premises under the control and management of the City for park and recreational purposes.

3. No person shall in any park or recreational area:
  - (a) ride, park or drive any all terrain vehicle, animal, motorized snow vehicle motor vehicle, trailer, bicycle, carriage, wagon, sleigh or any

other vehicle or conveyance of any description and of whatever motive power except upon the roadways or trails therein which have been designated by Council for such vehicular use;

- (b) ride, park or drive any all terrain vehicle, animal, motorized snow vehicle motor vehicle, trailer, carriage, wagon, sleigh or any other vehicle or conveyance of any description and of whatever motive power upon a roadway or trail which has been designated by Council as a hiking trail;
- (c) walk upon prepared ground, newly seeded ground, sodded ground or ground under repair or upon lawn upon which a sign prohibiting walking is posted;
- (d) willfully cause injury to any person or damage to any park property or recreational property by any means whatsoever;
- (e) shoot an arrow or practice archery or operate power model aircraft except in areas designated by Council and with a sign posted permitting the same;
- (f) play or practice golf or strike a golf ball except in those areas designated by Council and with a sign posted permitting the same;
- (g) distribute or expose any kind of commercial circular or advertisement or post, paint, stencil or otherwise affix any notice or bill or other paper to any tree, bush, shrub, fence, building or structure;
- (h) unless authorized by the Council and after having obtained all necessary licenses, sell or keep for sale any goods of any kind;
- (i) as owner or person having the control of any animal or dog, permit such animal or dog to run unleashed or permit such animal to swim in any water in or adjoining any park, bathing beach or swimming pool;
- (j) drive a Motorized Snow Vehicle and All-Terrain Vehicle except where such Motorized Snow Vehicle and All-Terrain Vehicle is expressly permitted to operate under conditions determined by the Director;
- (k) park any motor vehicle for more than a reasonable length of time at any time such determination of reasonableness to be made by the Director whose decision shall be final and binding;

- (l) trap, hunt, fish or kill or **attempt** to kill any animal, fish or bird;
  - (m) destroy or damage or disturb the nest or den of any bird or animal.
4. Unless authorized and permitted by the Council, no person shall in any park or recreational area;
- (a) perform for reward any art, skill or service;
  - (b) dig or tear up any pavement, sidewalk, crosswalk, grass plot or roadway or any part thereof;
  - (c) cut, destroy or damage in any way any tree, flower, plant, shrub or flowerbed;
  - (d) operate any amplifying system, loudspeaker or radio without a permit from the Director;
  - (e) light or build a fire except in fireplaces provided for in specially designated areas after having first obtained a permit to do so from the Director;
  - (f) moor or beach a boat in other than areas designated by the Council;
  - (g) place, maintain or allow to remain therein any coin-operated machine or game of any nature or kind;
  - (h) organize or arrange a picnic of more than fifty (50) persons;
  - (i) erect, construct, build or cause to be erected, constructed or built any tent, shelter or building.

### **Bathing Regulations**

5. No person shall in any park or recreation area:
- (a) enter or bathe in any water in or **adjoining** any park, bathing beach or swimming pool without being properly clothed in a bathing suit;
  - (b) dress or undress in or adjacent to any water in or adjoining any park, bathing beach or swimming pool except in the places specifically provided for such purpose;
  - (c) loiter in any bathhouse or bathing station;

- (d) bring to any bathing beach or swimming pool or the waters adjacent thereto any underwater spear or shooting device or inflatable object;
  - (e) being a male person enter any portion of any bathhouse set apart for the use of female persons, or being a female person enter any portion of any bathhouse set apart for the use of male persons;
  - (f) enter or bathe in any water in or adjoining any park where a sign is posted stating that bathing or swimming is not permitted.
    - a. No person shall enter or use the parks listed in Schedule "A" hereto annexed or any facilities thereof between the hours of 10:00 p.m. and 7:00 a.m. which time period shall be referred to as the park's closure time. The park's closure times shall not apply to individuals engaged as participants in or spectators of sports or other activities organized, administered, or approved by the Director. A letter signed by the Director confirming that the Director has organized, administered or approved any such activity shall be deemed conclusive proof of such exemption.
    - b. The Council or Director may cause signs to be erected calling attention to any of the provisions of these Regulations.
    - c. No person shall use any recreational or park facility without having paid the fee prescribed therefore, if any.
9. Where any person contravenes any of the provisions of these Regulations such person is guilty of an offence and liable on summary conviction to a fine or to a period of imprisonment in accordance with s. 438 of the *City of Corner Brook Act*;
10. These regulations shall come into force as of the date enacted by Council and the City of Corner Brook Parks By-law 1987 and all amendments thereto are hereby repealed upon the coming into force of these Regulations
